## PLEASE READ THOROUGHLY

### ENTRY QUALIFICATIONS

Only Canadian produced crafts or art will be considered. Submissions will be judged for quality and originality of design, craftsmanship and overall balance of craft categories. Products produced from commercial kits or moulds, "hobby crafts" or commercially manufactured goods will not be accepted. Approximately 160 10' by 10' booth spaces will be available in this years show.

### APPLICATION PROCEDURE

Please carefully complete and sign two copies of the third page of this form and return both copies to us. On acceptance, one copy will be returned to you. Include at least FIVE photographs (not slides or DVD's), and applicable payment as described below. **Pictures will NOT be returned without an adequately sized envelope with sufficient postage included. We reserve the right to retain photographs. The deadline for application is March 15, 2010.**

## CONDITIONS, RULES AND REGULATIONS OF AGREEMENT

Read carefully to avoid misunderstanding

**JURYING** Craftsman selection is solely at the discretion of Beaches Arts and Crafts Show. Exhibit space will be allocated at the discretion of Beaches Arts and Crafts Show. We reserve the right to relocate exhibits which may be affected by a change in the layout plan or in the interest of optimum traffic control and exhibit exposure. Beaches Arts and Crafts Show cannot be held liable if competitive exhibitors are opposite or adjacent to each other.

**TERMINATION** Beaches Arts and Crafts Show reserves the right to terminate the Exhibitors lease at any time if, in their sole opinion, the Exhibitor is displaying or selling products not representative of the work or calibre of work for which the Exhibitor was selected. Without limiting the generalities of the aforementioned, this includes goods or products deemed to be commercially manufactured. The conditions of the Exhibitor being allowed to exhibit are that the craft be handcrafted and be produced in Canada and that the Exhibitor displays and sells only the accepted craft as specified in this contract.

Beaches Arts and Crafts Show shall have the absolute right to terminate this agreement forthwith without notice if, in their opinion, the Exhibitor is guilty of any breach of any covenant contained herein. Any payment made by the Exhibitor to Beaches Arts and Crafts Show on account hereof will be retained by Beaches Arts and Crafts Show as liquidated damages for breach of contract and Beaches Arts and Crafts Show may thereupon rent said space.

The Show Manager shall have the right to reject or prohibit any Exhibitor who is objectionable to other participants. Without limiting the generalities of the aforementioned, this applies to persons, conducts, printed matter, souvenirs or novelties which may affect the overall show presentation. "Reduced Price" and "Sale" or other signs of this nature are not permitted. The price of the work on display should not be altered or changed during the show and no "seconds" are permitted to be sold.

**NSF CHEQUES** The Exhibitor agrees to pay a service charge of \$25.00 (twenty-five) for each and every cheque returned to Beaches Arts and Crafts Show from the Exhibitors bank, trust company or credit union, whatever the reason.

**MUNICIPAL REQUIREMENTS** The Exhibitor agrees to assume responsibility for compliance with all rules and regulations held within the Exhibitor's contract respecting

the conduct and management of the show. Without limiting the generalities of the aforementioned, this includes all federal, provincial and municipal laws which apply to the Exhibitors use of the facilities for the show including the charging of applicable taxes.

**INSURANCE** The Exhibitor undertakes and agrees with Beaches Arts and Crafts Show to indemnify and save harmless from any and all claims arising out of the Exhibitor's use of the facilities and to indemnify and save harmless Beaches Arts and Crafts Show from any and all claims and liabilities for any loss, damage, theft or destruction whatsoever or however caused to any goods, or any property belonging to the Exhibitor or for which the Exhibitor is responsible beyond the rental fee paid in the event of cancellation of the show for whatever reason. The Exhibitor undertakes and agrees with Beaches Arts and Crafts Show that he/she exhibits entirely at his/her own risk and shall be liable for any and all loss whatsoever, caused by the Exhibitor, his/her servants or agents or the goods, exhibits or other property belonging to the Exhibitor, or for which the Exhibitor is responsible. Exhibitors are strongly urged to cover themselves against the risk of loss or damage or liability however caused.

**SET UP AND TAKE DOWN** Exhibitors must set up their displays within the time specified in the contract acceptance letter. Any booth remaining unoccupied two hours prior to show opening shall be reassigned at the Show Managers discretion without compensation to the Exhibitor.

In the event of an Exhibitor's booth not being open at any time during show hours, the Show Manager shall have the right to open said booth by removal of any night sheets or other coverings of any sort, but shall not be liable to the Exhibitor for any loss or damage which may be caused thereby, or as a result of the booth being opened in that way and then being left unattended.

No Exhibitor shall disassemble, pack up or remove any part of his/her display before the official closing time. Exhibitors who do so will forfeit any and all rights to participate in future shows produced by Beaches Arts and Crafts Show. All exhibits must be fully removed from the area within the time period specified in the contract acceptance letter.

Exhibitor's displays must not protrude beyond the measured booth and may not be taller than 8 (eight) feet.
